With a view to ensuring greater safety for navigation on the Rhine and providing skippers with more information, the CCNR introduced an obligation to fit Inland AIS devices and Inland ECDIS or comparable devices for displaying electronic charts, in force since 1 December 2014. The obligation applies on the Rhine; full information on the decision can be consulted in the brochure available at "[Clarifications concerning the obligation of equipment with an Inland AIS and an Inland ECDIS device or a comparable electronic chart display device](#)". The prescriptions applicable are included in Article 4.07 of the Police Regulations for the Navigation of the Rhine (RPNR), which can be downloaded at : [RPNR](#).

The decision has been in force for two years now, and the CCNR would like to carry out an assessment to find out what people's experience of it has been and what difficulties have been encountered, thereby providing the parties affected by the new regulations with an opportunity to propose improvements. This will enable the CCNR to take account of grassroots requirements and constraints when drawing up future regulations, and it is therefore inviting anyone who wishes to take part in the assessment of these prescriptions and their evolution to answer an anonymous on-line questionnaire, accessible at:

The questionnaire will be available, in French, Dutch and German, from 1 November to mid-December; there is a separate questionnaire for each of the four levels concerned by the regulations:

- » Boatman
- » Police or supervisory authority boarding vessels
- » Waterway or port management authority
- » Company fitting or repairing Inland AIS devices

Please make this questionnaire known to others around you; be assured that your time and effort spent on the questionnaire will be much appreciated! The main conclusions of the assessment will be available once the results have been analysed.
