

Administrative arrangement on the mutual recognition of service record books

Preamble

The Central Commission for the Navigation on the Rhine (hereinafter “the CCNR”)

and the following national Administrations :

Ministry of Transport, Innovation and Technology of the Republic of Austria
Ministry of Transport, information technology and communications, Maritime Administration, of the Republic of Bulgaria
Ministry of national development of Hungary
Ministry of Infrastructure of the Republic of Poland
Ministry of Transport and Infrastructure of Romania
Ministry of Transport, Construction and Regional Development of the Slovak Republic
Ministry of Transport of the Czech Republic

(Hereinafter “the contracting Administrations”),

Wishing to simplify the obligations incumbent on professionals and facilitate the free circulation of crew members,

Aware that the mutual recognition of service record books in Europe, by facilitating the free circulation of crew members in Europe, is a measure that would help to address the current shortage of personnel in the sector,

Noting the great similarity among the service record books used in Europe regarding all the information noted therein other than qualifications,

Wishing to take action rapidly, on as wide a European basis as possible,

Referring in this respect to the desire to accelerate pan-European cooperation with a view to liberalising and reinforcing inland waterway transport as expressed at the Pan-European Conferences in Rotterdam (2001) and Bucharest (2006),

Noting that the conclusion of this multilateral arrangement for the mutual recognition of service record books in no way prevents the conclusion, in parallel and in addition, of bilateral arrangements between the CCNR and certain contracting Administrations or between contracting Administrations, for the mutual recognition of qualifications,

Convinced of the usefulness of pursuing at the same time their work on the mutual recognition of qualifications based on diplomas and training courses in inland navigation,

Noting that the mutual recognition of service record books should be accompanied by mechanisms for administrative cooperation among the competent authorities, more particularly in order to lay down the methods for making entries in the recognised service record books, to develop common practices, and to set up reliable systems for the exchange of information,

Acknowledging that in the long term it will be desirable to ensure that a person may hold only one service record book,

Have agreed the following Arrangement.

Article 1

Competent authorities

The competent authorities are the authorities authorised to issue service record books and to stamp them.

The list of Rhine authorities competent for issuing Rhine service record books and for stamping them is given in Annex 1.

The list of authorities of the contracting Administrations competent for issuing national service record books and for stamping them is given in Annex 2.

Article 2

Mutual recognition

1. The CCNR shall recognise the validity on the Rhine of the national service record books issued by the competent authorities of the contracting Administrations.
2. The contracting Administrations shall recognise the validity on the waterways located on the national territory of their States of the service record books issued by the competent Rhine authorities and by the competent authorities of the other contracting Administrations.

Article 3

Records kept by the issuing authority

1. Each competent authority shall maintain a register of the service record books it has issued. This register shall include the following data as a minimum:
 - number of the service record book,
 - date of issue,
 - the holder's first and last names,
 - the holder's date and place of birth,
 - the nationality and type of identity document presented,
 - the qualification of the holder.
2. Each competent authority shall also keep a file in respect of every holder of a service record book it has issued, which shall contain more particularly:
 - copies of certificates and diplomas corresponding to the qualifications entered in the service record book,
 - a copy of the evidence of navigation time, if the qualification was obtained on the basis of the required navigation time,
 - a medical certificate attesting the mental and physical fitness of the holder.

Article 4

Exchange of information

1. Upon request, a specimen of each recognised service record book shall be supplied to any competent authority listed in Annexe 1 or 2 which wishes to receive them.
2. Upon request, each competent authority shall make any information listed in Article 3 concerning the service record books it has issued available to any competent authority.

Article 5

Entries made by competent authorities in recognised service record books

1. Medical fitness

- The competent Rhine authorities shall be the only authorities competent to make entries in a Rhine service record book concerning the holder's medical fitness, and such entries shall comply with Rhine regulations. They shall be recognised as valid on the waterways located on the national territories of all the contracting Administrations.
- The competent authorities of the issuing State shall be the only authorities competent to make entries in a national service record book concerning the holder's medical fitness, and such entries shall comply with the national regulations of the issuing State. The contracting Administrations shall recognise the validity of these entries on the waterways located on their national territories, and the CCNR shall recognise the validity of these entries on the Rhine.

2. Stamping in respect of journeys and navigation time completed

Journeys and navigation time completed may be stamped in recognised service record books by any competent authority as defined in Article 1.

3. Qualification

- The competent Rhine authorities alone shall be authorised to enter in any service record book (Rhine or other) the indications concerning the qualification of the book's holder in compliance with Rhine regulations. These shall be entered on the page of the service record book reserved for qualifications in compliance with Rhine regulations. These entries are the only ones that are recognised as valid on the Rhine.
- The competent national authorities of the issuing State alone shall be authorised to enter in a national service record book the indications concerning the qualification of the book's holder in compliance with national regulations. These shall be entered on the page of the national service record book reserved for this purpose. They may also be entered on the page of the Rhine service record book reserved for qualifications in compliance with regulations valid on waterways other than the Rhine. Such entries shall not be recognised as valid on the Rhine.

Article 6

Joint meetings

A joint meeting shall be organised whenever necessary, to be attended by the national experts of the CCNR and of the contracting Administrations. The river commissions and the European Commission may be represented. The purposes of the joint meetings shall be, *inter alia*:

- to contribute to ensuring that the evolution and adaptation of the regulations which will be necessary in the future are in line with the various regulations,
- to discuss and address any implementation difficulties encountered or infringements noted,
- to examine and develop procedures for the exchange of information,
- to coordinate the enforcement mechanisms in the States,
- to compare the ways of obtaining qualifications and to make progress with the mutual recognition of qualifications.

Article 7

Secretariat of the Arrangement

A Secretariat of the Arrangement (hereinafter "the Secretariat") shall be instituted. It shall be provided by the Secretariat of the CCNR, and shall be located in Strasbourg. Its main tasks shall consist of:

- supplying the logistical assistance necessary for organising the joint meetings referred to in Article 6,
- keeping up to date the list of the competent authorities given in Annexes 1 and 2,
- facilitating the exchange of information among the contracting Administrations and between these and the CCNR, as well as between the competent authorities defined in article 1,
- operating a specific page of the CCNR Internet site on which information concerning the application of the Arrangement may be consulted, and
- carrying out other tasks that may be necessary to ensure the proper functioning of the Arrangement.

Article 8

Duty to inform and act in concertation if the regulations are amended

The CCNR and the contracting Administrations shall inform each other as soon as possible and independently of the joint meetings on amendments and developments envisaged in respect of their regulations. They shall consult each other before their adoption, in order to prevent amendments that might jeopardise the mutual recognition of service record books. In the event of modification, they shall transmit the amended regulation to the Secretariat without delay, specifying its date of entry into force. The Secretariat shall be responsible for circulating this information to the CCNR and to all the contracting Administrations.

Article 9

Ending mutual recognition

1. If the CCNR or a contracting Administration is of the view that a regulatory amendment adopted by one of the States involved in the Arrangement or that any of the practices of a contracting Administration might jeopardise mutual recognition, it shall inform the Secretariat accordingly without delay, and the Secretariat shall transmit the information to the CCNR and to all the contracting Administrations. The latter shall strive to find an amicable solution to maintain the mutual recognition of service record books. A joint meeting may be convened for this purpose.
2. If by the end of the negotiation the CCNR or one of the contracting Administrations is still convinced that mutual recognition cannot be maintained any longer without endangering the safety of navigation, it may end mutual recognition in respect of the contracting Administration concerned. This decision shall take effect in respect of the contracting Administration concerned twelve months after receipt of the notification by the Secretariat.

Article 10

Amendments

1. Amendment to the Annexes to the present Arrangement

The CCNR and the contracting Administrations shall notify the Secretariat without delay of any amendment concerning the list of competent authorities given in Annexes 1 and 2. The Secretariat shall amend the Annex concerned accordingly and transmit it to the CCNR and to the contracting Administrations as soon as possible.

2. Amendment to the Arrangement

The CCNR or a contracting Administration may submit proposals for amending the Arrangement to the Secretariat. The CCNR and the contracting Administrations shall notify the Secretariat of their position and send their comments, within two months following the Secretariat's notification of the proposal. In their replies they shall state more particularly whether they wish a joint meeting to be convened. Failure to reply within this two-month period shall be deemed to constitute agreement to the proposal. Amendments shall enter into force sixty days after being approved. The Secretariat shall circulate an amended version of the Arrangement to the CCNR and all the contracting Administrations before the date on which the amendment comes into force.

Article 11

Final provisions

1. The Arrangement shall enter into force on 01 July 2011.


The CCNR and the contracting Administrations shall notify the Secretariat in writing as soon as possible and no later than 1 July 2011, that the internal formalities required for entry in force of the Arrangement, have been completed. The Secretariat shall inform the CCNR and the contracting Administrations accordingly.

2. Any national Administration whose record service book meets the criteria specified in CCNR Resolution 2008-II-8 may apply for accession to the Arrangement. Accession requires the consent of the CCNR and all contracting Administrations. It shall be without reservation and apply to the Arrangement in its form valid at the time of accession. The formal application to accede shall be lodged with the Secretariat, which shall communicate it to the CCNR and the contracting Administrations immediately. The accession shall be deemed accepted at the end of a period of six months following the date of communication of the application, unless the CCNR or any contracting Administration issues an objection in writing. Any such objection shall be examined at a joint meeting. Accession would then be subject to unanimous acceptance by the parties present at the joint meeting. Parties not represented at the joint meeting shall have one month to issue any objections. Accession shall take effect three months after acceptance by the CCNR and all the contracting Administrations, according to the procedure mentioned above.
3. The CCNR or any contracting Administration may withdraw from the Arrangement, by means of a written notification addressed to the Secretariat, which shall inform the CCNR and the contracting Administrations. The withdrawal shall take effect twelve months after receipt of the notification by the Secretariat.
4. The Arrangement does not constitute a treaty or international agreement under public international law, involving the international responsibility of the contracting Administrations as States or of the CCNR as an international organisation. It is concluded without prejudice to the rights and obligations resulting from any international agreement or EU regulation.
5. The French, German, Dutch and English texts of the Arrangements shall be equally authentic. The signed copies shall be deposited with the Secretariat. A certified true copy in each language shall be given to the CCNR and to each of the contracting Administrations. Each contracting Administration shall have the Arrangement translated into its official national language.




