   The institutions and persons covered by this Regulation shall have a duty of mutual information and cooperation to ensure the correct implementation of this Regulation

# Background: data exchange between issuing and AL organisation


- Determination of the applicable legislation regular process
- Suspicion of misuse/abuse
- Assessment of a risky situation
  - When the owner of the vessel is seated in a different Member State than the operator

Moments to share data


- Once status quo

# Background: data exchange between issuing and AL organisation


The organisation could then provide the following data:

- Name and ENI Rhine vessel (common denominator of all information)
- Name, address, country of shipowner (+ possible legal form of company)
- Name, address, country of operator of vessel (+ possible legal form of company)
- Date of change in operator of vessel
- The (completed) application form for the RC and any relevant documents sent along, such as the CE form and the operating agreement between the shipowner and the operator.




# Legal basis for data exchange between issuing and AL organisation

- The Netherlands leading delegation data exchange CASS
- Legal basis needs to be created
- GDPR is applicable
- DPIA
- Sensitivity of the data



### **DPIA**


- Instrument to identify privacy risks of data sharing
- Required because of article 35 GDPR
- DPIA is specifically required in case of:
  - a systematic and extensive evaluation of personal aspects relating to natural persons which is based on automated processing, including profiling, and on which decisions are based that produce legal effects concerning the natural person or similarly significantly affect the natural person;
- Key points of the DPIA form:
  - Systematic description of the envisaged processing operations
  - Assessment of the necessity and proportionality
  - Assessment of the risks
  - Mitigation of risks


- Prescan DPIA
- DPIA
- Amendment of a Dutch Ministerial Decree
- Exchange of data between issuing and AL organisation



## Data exchange in the Netherlands - DPIA


#### **Key points DPIA**

- SVB and ILT are involved parties data processing agreement
- ILT is owner of the data
- SVB is processor of the data
- Ministry of Social Affairs and Employment provides national legal basis



## Data exchange in the Netherlands - DPIA

- Purpose of data exchange
  - SVB: determining applicable legislation and enforcement
  - ILT: authenticating and updating the registers
- Description of data process
  - Which personal data
  - Mitigation of risks
